They told me that there -- my 3 4 job would be there for me after I give birth. I worked 5 overtime. They give me, they extended overtime for me, and I 6 would missout on my daughter, have my mom or my husband watch my 7 daughter while I'm doing my thing working hard, and I felt 8 embarrassed. I felt embarrassed when they fired me for my pregnancy. 9
